4-H Camperships

4-H Campership Gift Fund Request Guidelines

The Campership Gift Fund has been established to support 4-H counselors and campers in Portage County. This fund is designed to help reduce the cost of camp for eligible members and promote participation in 4-H programs outside of 4-H Club activities.

Eligibility and Use of Funds:

- For counselors and campers who are active members of a 4-H Club in Portage County.
- Funds are provided to offset camp costs
 - Counselors: \$50.00 will automatically be applied to camp fees paid directly to Camp Whitewood
 - Campers: Families with multiple children attending camp will receive \$100 for each additional camper beyond the first to be applied directly to Camp Whitewood.

Application Process:

1. The funding request form for camperships will be available in January.
2. Submit the completed form along with camp registration by May of the current year.
3. Requests will be reviewed, and funding decisions will be communicated to the families and to Camp Whitewood.

If Approved:

- Funds for counselors will automatically be applied before camper fees are due.
- Camperships for campers will be processed directly with Camp Whitewood. The Portage County Extension of The Ohio State University will work with the families and Camp Whitewood to ensure payment is paid for camperships.

Important:

Only members of Portage County 4-H Clubs are eligible for this funding.
